**TERMS AND CONDITIONS FOR LICENSE TO OPERATE OF COLD STORAGE FACILITY**

1. This License to Operate (LTO) remain valid only if the company/cold storage facility aforementioned have passed the audit assessment in accordance to the evaluation criteria used by the Regulatory Office – Inspectorate Team and endorsed by the accreditation Committee Technical Working Group, with no violation to the provision set in the DA AC No. 01, series of 2021, and BPI AC No. 1, series of 2021 to wit.
2. This LTO must be displayed on a conspicuous place within the business establishment.
3. The cold storage operators and the licensed CSW must comply with the terms and conditions of BPI’s issuance of license to operate in accordance to section 9 of DA AC No. 01, series of 2021 and Section 10 of BPI AC No.1 series of 2021, hereof:
  - 3.1 The CSW operators shall:
    - Fully cooperate with the BPI in the implementation of AC No. 01, series of 2021;
    - Support the traceability system for food products advocated by the BPI and DA;
    - Designate Food Safety Compliance Officer (FSCO) to submit Food Safety Plan/Internal Control System annually to BPI as part of their duties and responsibilities
    - Allow duly authorized officers/inspectors of the RO to enter and inspect the CSW premises during reasonable hours and conditions;
    - Allow the verification and evaluation of relevant records or documents;
    - Provide assistance as may be needed to enable BPI to conduct inspection and testing efficiently and effectively;
    - Communicate immediately with BPI for any technical problems that may arise;
    - Disallow the unloading of imported products for storage in the absence of representative from BPI;
    - Disallow the release of commodities in which a hold order is issued.
4. This LTO shall be valid for two (2) years unless revoked earlier
5. The LTO is not transferable and shall not be used in any place other than the one stated in the certificate.
6. The LTO of cold storage operators may be revoked, cancelled or suspended for violation of the AC No. 01, series of 2021, BPI AC No.01, series of 2021 and other pertinent laws.
