**AFFIDAVIT OF UNDERTAKING**

**A. LICENSE TO OPERATE**

1. The LTO Shall be signed by the owner and posted in a conspicuous place where establishment is located. A photocopy of this duly notarized affidavit of undertaking shall be forwarded to its respective Regional Technical Operation Center for legal record-keeping and documentation purposes.
2. The LTO shall apply and submit all mandatory technical and documentary requirements for renewal within sixty (60) days before its expiration date.

**B. OPERATION**

1. The operator shall comply with the regulations relative to adoption of GMP/SSOP/HACCP in the operation of the meat establishment (DA AO 21 s. 2004 and DA AO 09 s.2003)
2. The operator shall have the obligatory responsibility to maintain meat establishment in good operating condition at all times and to comply with the meat hygiene and inspection regulations.
3. The operator shall not allow any person to withdraw and transfer any carcass of stored carcass, or any of its parts to other destinations without the corresponding Meat Inspection Certificate/s (MIC) for locally produced meat and Certificate of Meat Inspection (COMI) for imported meat issued by NMIS Meat Inspection Officer.
4. The operator shall ensure that only valid registered Meat Transport Vehicle (MTV) is allowed to transport/distribute their meat and meat by-products nationwide and compliant to GMP/SSOP/HACCP program of the meat establishment.

**C. RECORD KEEPING**

1. The operator shall keep and maintain records, reports and information, and shall fully and correctly disclose all transactions in the operation of the meat establishment relative to meat safety and quality assurance. Such records and information shall be made available upon the request of the NMIS Technical Officers for regulatory monitoring, validation, and verification purposes.

**D. COORDINATION**

1. The operator shall notify officially the concerned NMIS Regional Technical Operation Centers (RTOCs) regarding any plan of changes of facility or operations, business name for technical assistance and approval.
2. The operator shall maintain compliance to RA 9296; RA 10611 and other pertinent meat inspection laws, rules and regulations of the Department of Agriculture and all other applicable laws.

**E. OTHERS**

1. The LTO shall be automatically cancelled should there be a violation with other concerned regulatory agencies.

**GROUND FORS SUSPENSION/REVOCAION**

1. Non-renewal of License to Operate (LTO) will mean **recall of NMIS Meat Inspection Officer** and documents/paraphernalia related to inspection and issuance of certifications. **Transport of meat and meat by-products beyond the city or municipality shall not be allowed.**
2. Failure by the Operator to comply with the above stated conditions and requirements shall result to suspension or revocation of the License to Operate (LTO) after due process.
